# A note on some constants related to the zeta-function and their relationship with the Gregory coefficients

#### Abstract

In this article, new series for the first and second Stieltjes constants (also known as generalized Euler's constant), as well as for some closely related constants are obtained. These series contain rational terms only and involve the so-called Gregory coefficients, which are also known as the (reciprocal) logarithmic numbers, the Cauchy numbers of the first kind and the Bernoulli numbers of the second kind. In addition, two interesting series with rational terms for Euler's constant $\gamma$ and the constant $\ln 2 \pi$ are given, and yet another generalization of Euler's constant is proposed and various formulas for the calculation of these constants are obtained. Finally, we mention in the paper that almost all the constants considered in this work admit simple representations via the Ramanujan summation.

## 1 Introduction and definitions

The zeta-function

$$
\zeta(s):=\sum_{n=1}^{\infty} n^{-s}, \quad \operatorname{Re} s>1
$$

is of fundamental and long-standing importance in analytic number theory, modern analysis, theory of $L$-functions, prime number theory and in a variety of other fields. The $\zeta$-function is a meromorphic function on the entire complex plane, except at the point $s=1$ at which it has one simple pole with residue 1 . The coefficients of the regular part of its Laurent series, denoted $\gamma_{m}$,

\zeta(s)=\frac{1}{s-1}+\gamma+\sum_{m=1}^{\infty} \frac{(-1)^{m}(s-1)^{m}}{m!} \gamma_{m}, \quad s \neq 1 \tag{1}
\end{equation*}
$$

where $\gamma$ is Euler's constant, ${ }^{1}$ and those of the MacLaurin series $\delta_{m}$

$$
\begin{equation*}
\zeta(s)=\frac{1}{s-1}+\frac{1}{2}+\sum_{m=1}^{\infty} \frac{(-1)^{m} s^{m}}{m!} \delta_{m}, \quad s \neq 1 \tag{2}
\end{equation*}
$$

are of special interest and have been widely studied in the literature, see e.g. [25], [21, vol. I, letter 71 and following], [23, p. 166 et seq.], [2,4,9,16,18, 19,24,26,28-30,33-35,38]. The coefficients $\gamma_{m}$ are usually called Stieltjes constants or generalized Euler's constants (both names being in use), while $\delta_{m}$ do not possess a special name. ${ }^{2}$ It may be shown with the aid of the Euler-MacLaurin summation that $\gamma_{m}$ and $\delta_{m}$ may be also given by the following asymptotic representations

\end{equation*}

and

$$
\begin{align*}
\delta_{m} & =(-1)^{m} m!+\lim _{n \rightarrow \infty}\left\{\sum_{k=1}^{n} \ln ^{m} k-n m!\sum_{k=0}^{m}(-1)^{m+k} \frac{\ln ^{k} n}{k!}-\frac{\ln ^{m} n}{2}\right\}, \\
m & =1,2,3, \ldots \tag{4}
\end{align*}
$$

[^1]These representations may be translated into these simple expressions

$$
\gamma_{m}=\sum_{k \geqslant 1}^{\mathcal{R}} \frac{\ln ^{m} k}{k}, \quad \delta_{m}=\sum_{k \geqslant 1}^{\mathcal{R}} \ln ^{m} k, \quad m=1,2,3, \ldots,
$$

where $\sum^{\mathcal{R}}$ stands for the sum of the series in the sense of the Ramanujan summation of divergent series. ${ }^{5}$ Due to the reflection formula for the zeta-function $\zeta(1-s)=2 \zeta(s) \Gamma(s)(2 \pi)^{-s} \cos \frac{1}{2} \pi s$, the numbers $\delta_{m}$ and $\gamma_{m}$ are related to each other polynomially and also involve Euler's constant $\gamma$ and the values of the $\zeta$-function at naturals. For the first values of $m$, this gives

\delta_{1} & =\frac{1}{2} \ln 2 \pi-1=-0.08106146679 \ldots, \\
\delta_{2} & =\gamma_{1}+\frac{1}{2} \gamma^{2}-\frac{1}{2} \ln ^{2} 2 \pi-\frac{1}{24} \pi^{2}+2=-0.006356455908 \ldots,{ }^{6} \\
\delta_{3} & =-\frac{3}{2} \gamma_{2}-3 \gamma_{1} \gamma-\gamma^{3}-\left(3 \gamma_{1}+\frac{3}{2} \gamma^{2}-\frac{1}{8} \pi^{2}\right) \ln 2 \pi+\zeta(3)+\frac{1}{2} \ln ^{3} 2 \pi-6 \\
& =+0.004711166862 \ldots
\end{aligned}
$$

and conversely

$$
\begin{align*}
\gamma_{1}= & \delta_{2}+2 \delta_{1}^{2}+4 \delta_{1}-\frac{1}{2} \gamma+\frac{1}{24} \pi^{2}=-0.07281584548 \ldots, \\
\gamma_{2}= & -\frac{2}{3} \delta_{3}-2 \delta_{2}(\gamma+2)-4 \delta_{1} \delta_{2}-\frac{16}{3} \delta_{1}^{3}-4 \delta_{1}^{2}(\gamma+4) \\
& -8 \delta_{1}(\gamma+1)-\frac{1}{12} \gamma \pi^{2}+\frac{1}{3} \gamma^{3}+\frac{2}{3} \zeta(3)-\frac{4}{3} \\
= & -0.009690363192 \ldots \tag{5}
\end{align*}

The relationships between the higher-order coefficients become very cumbersome, but may be found via a semi-recursive procedure described in [1]. Although there exist numerous representations for $\gamma_{m}$ and $\delta_{m}$, no convergent series with rational terms only are known for them (unlike for Euler's constant $\gamma$, see e.g. [4, Sect. 3], or for various expressions containing it [6, p. 413, Eqs. (41), (45)-(47)]). Recently, divergent enveloping series for $\gamma_{m}$ containing rational terms only have been obtained in [4, Eqs. (46)-(47)]. In this paper, by continuing the same line of investigation, we derive convergent series representations with rational coefficients for $\gamma_{1}, \delta_{1}, \gamma_{2}$ and $\delta_{2}$, and also find two new series of the same type for Euler's constant $\gamma$ and $\ln 2 \pi$, respectively. These series are not simple and involve a product of the Gregory coefficients $G_{n}$, which are also known as the (reciprocal) logarithmic numbers, the Bernoulli numbers of the second kind $b_{n}$, and the normalized Cauchy numbers of the first kind $C_{1, n}$. Similar expressions for the higher-order constants $\gamma_{m}$ and $\delta_{m}$ may be obtained by the same procedure, using the harmonic product of sequences introduced in [12], but are quite cumbersome. Since the Stieltjes constants $\gamma_{m}$ generalize Euler's

[^2]constant $\gamma$ and since our series contain the product of $G_{n}$, these new series may also be seen as the generalization of the famous Fontana-Mascheroni series
\[

$$
\begin{equation*}
\gamma=\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n}=\frac{1}{2}+\frac{1}{24}+\frac{1}{72}+\frac{19}{2880}+\frac{3}{800}+\frac{863}{362880}+\frac{275}{169344}+\cdots \tag{6}
\end{equation*}

which is the first known series representation for Euler's constant having rational terms only, see [6, pp. 406, 413, 429], [4, p. 379]. In Appendix, we introduce yet another set of constants $\kappa_{m}=\sum_{n \geqslant 1}\left|G_{n}\right| n^{-m-1}$, which also generalize Euler's constant $\gamma$. These numbers, similarly to $\gamma_{m}$, coincide with Euler's constant at $m=0$ and have various interesting series and integral representations, none of them are reducible to "classical" mathematical constants.

## 2 Series expansions

### 2.1 Preliminaries

Since the results that we come to present here are essentially based on the Gregory coefficients and the Stirling numbers, it may be useful to briefly recall their definition and properties. The Gregory numbers, denoted below $G_{n}$, are rational alternating $G_{1}=$ $+1 / 2, G_{2}=-1 / 12, G_{3}=+1 / 24, G_{4}=-19 / 720, G_{5}=+3 / 160, G_{6}=-863 / 60480, \ldots$, decreasing in absolute value, and are also closely related to the theory of finite differences; they behave as $\left(n \ln ^{2} n\right)^{-1}$ at $n \rightarrow \infty$ and may be bounded from below and above according to [6, Eqs. (55)-(56)]. They may be defined either via their generating function

$$
\begin{equation*}
\frac{z}{\ln (1+z)}=1+\sum_{n=1}^{\infty} G_{n} z^{n}, \quad|z|<1 \tag{7}
\end{equation*}
$$

or recursively

$$
\begin{equation*}
G_{n}=\frac{(-1)^{n+1}}{n+1}+\sum_{l=1}^{n-1} \frac{(-1)^{n+1-l} G_{l}}{n+1-l}, \quad G_{1}=\frac{1}{2}, \quad n=2,3,4, \ldots \tag{8}
\end{equation*}
$$

or explicitly ${ }^{7}$

$$
\begin{equation*}
G_{n}=\frac{1}{n!} \int_{0}^{1} x(x-1)(x-2) \cdots(x-n+1) \mathrm{d} x, \quad n=1,2,3, \ldots \tag{9}
\end{equation*}
$$

Throughout the paper, we also use the Stirling numbers of the first kind, which we denote below by $S_{1}(n, l)$. Since there are different definitions and notations for them,

[^3]we specify that in our definition they are simply the coefficients in the expansion of falling factorial
\[

$$
\begin{equation*}
x(x-1)(x-2) \cdots(x-n+1)=\sum_{l=1}^{n} S_{1}(n, l) \cdot x^{l}, \quad n=1,2,3, \ldots, \tag{10}
\end{equation*}
$$

\]

and may equally be defined via the generating function

$$
\begin{equation*}
\frac{\ln ^{l}(1+z)}{l!}=\sum_{n=l}^{\infty} \frac{S_{1}(n, l)}{n!} z^{n}=\sum_{n=0}^{\infty} \frac{S_{1}(n, l)}{n!} z^{n}, \quad|z|<1, \quad l=0,1,2, \ldots \tag{11}
\end{equation*}
$$

It is important to note that $\operatorname{sgn}\left[S_{1}(n, l)\right]=(-1)^{n \pm l}$. The Stirling numbers of the first kind and the Gregory coefficients are linked by the relation

$$
\begin{equation*}
G_{n}=\frac{1}{n!} \sum_{l=1}^{n} \frac{S_{1}(n, l)}{l+1}, \quad n=1,2,3, \ldots, \tag{12}
\end{equation*}
$$

which follows directly from (9) and (10). ${ }^{8}$

### 2.2 Some auxiliary lemmas

Before we proceed with the series expansions for $\delta_{m}$ and $\gamma_{m}$, we need to prove several useful lemmas.

Lemma 1 For each natural number $k$, let

\sigma_{k}:=\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n+k}
$$

## the following equality holds

$$
\begin{equation*}
\sigma_{k}=\frac{1}{k}+\sum_{m=1}^{k}(-1)^{m}\binom{k}{m} \ln (m+1), \quad k=1,2,3, \ldots 9 \tag{13}
\end{equation*}
$$

[^4]Proof By using (12) and by making use of the generating equation for the Stirling numbers of the first kind (11), we obtain

$$
\begin{align*}
\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n+k} & =\sum_{n=1}^{\infty} \frac{1}{n!} \sum_{l=1}^{n} \frac{(-1)^{l+1}\left|S_{1}(n, l)\right|}{l+1} \cdot \underbrace{\int_{0}^{1} x^{n+k-1} \mathrm{~d} x}_{1 /(n+k)} \\
& =-\sum_{l=1}^{\infty} \frac{1}{(l+1)!} \int_{0}^{1} x^{k-1} \ln ^{l}(1-x) \mathrm{d} x \\
& =\sum_{l=1}^{\infty} \frac{(-1)^{l+1}}{(l+1)!} \int_{0}^{\infty}\left(1-\mathrm{e}^{-t}\right)^{k-1} t^{l} \mathrm{e}^{-t} \mathrm{~d} t \\
& =\sum_{l=1}^{\infty} \frac{(-1)^{l+1}}{(l+1)!} \sum_{m=0}^{k-1}(-1)^{m}\binom{k-1}{m} \underbrace{\infty}_{l!(m+1)^{-l-1}} \mathrm{e}^{-t(m+1)} t^{l} \mathrm{~d} t \\
& =\sum_{l=1}^{\infty} \frac{(-1)^{l+1}}{l+1} \sum_{m=0}^{k-1}(-1)^{m}\binom{k-1}{m} \frac{1}{(m+1)^{l+1}} \\
& =\sum_{m=0}^{k-1}(-1)^{m}\binom{k-1}{m}\left\{\frac{1}{m+1}-\ln \frac{m+2}{m+1}\right\}, \tag{14}
\end{align*}
$$

where at the last stage we made a change of variable $x=1-\mathrm{e}^{-t}$ and used the well-known formula for the $\Gamma$-function. But since

$$
\sum_{m=0}^{k-1} \frac{(-1)^{m}}{m+1}\binom{k-1}{m}=\frac{1}{k} \quad \text { and } \quad\binom{k-1}{m}+\binom{k-1}{m-1}=\binom{k}{m}
$$

the last finite sum in (14) reduces to (13).
Remark 1 One may show ${ }^{10}$ that $\sigma_{k}$ may also be written in terms of the Ramanujan summation:

$$

\sigma_{k}=\sum_{n \geqslant 1}^{\mathcal{R}} \frac{\Gamma(k+1) \Gamma(n)}{\Gamma(n+k+1)}=\sum_{n \geqslant 1}^{\mathcal{R}} B(k+1, n), \tag{15}
\end{equation*}
$$

where $B$ stands for the Euler beta-function.

Lemma 2 Let $a=(a(1), a(2), \ldots, a(n), \ldots)$ be a sequence of complex numbers. The following identity is true for all nonnegative integers $n$ :

\sum_{l=0}^{n}(-1)^{l}\binom{n}{l} \frac{a(l+1)}{l+1}=\frac{1}{n+1} \sum_{k=0}^{n} \sum_{l=0}^{k}(-1)^{l}\binom{k}{l} a(l+1) . \tag{16}

In particular, if $a=\ln ^{m}$ for any natural $m$, then this identity reduces to

$$

\sum_{l=0}^{n}(-1)^{l}\binom{n}{l} \frac{\ln ^{m}(l+1)}{l+1}=\frac{1}{n+1} \sum_{k=1}^{n} \sum_{l=1}^{k}(-1)^{l}\binom{k}{l} \ln ^{m}(l+1) \tag{17}
\end{equation*}
$$

Proof Formula (16) is an explicit translation of [12, Proposition 7].

## Lemma 3 For all natural m

$$
\begin{align*}
\gamma_{m} & =\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{k=1}^{n} \sum_{l=1}^{k}(-1)^{l}\binom{k}{l} \ln ^{m}(l+1)  \tag{18}\\
\delta_{m} & =\sum_{n=1}^{\infty}\left|G_{n+1}\right| \sum_{l=1}^{n}(-1)^{l}\binom{n}{l} \ln ^{m}(l+1) . \tag{19}
\end{align*}
$$

Proof Using the representation

$$
\zeta(s)=\frac{1}{s-1}+\sum_{n=0}^{\infty}\left|G_{n+1}\right| \sum_{k=0}^{n}(-1)^{k}\binom{n}{k}(k+1)^{-s}, \quad s \neq 1,
$$

see e.g. [4, pp. 382-383], [5], ${ }^{11}$ we first have

$$
\gamma_{m}=\sum_{n=0}^{\infty}\left|G_{n+1}\right| \sum_{l=0}^{n}(-1)^{l}\binom{n}{l} \frac{\ln ^{m}(l+1)}{l+1}
$$

and

$$
\delta_{m}=\sum_{n=0}^{\infty}\left|G_{n+1}\right| \sum_{l=0}^{n}(-1)^{l}\binom{n}{l} \ln ^{m}(l+1) .
$$

Then formula (18) follows from (17).

### 2.3 Series with rational terms for the first Stieltjes constant $\gamma_{1}$ and for the coefficient $\delta_{1}$

Theorem 1 The first Stieltjes constant $\gamma_{1}$ may be given by the following series:

$$
\begin{align*}
\gamma_{1}= & \frac{3}{2}-\frac{\pi^{2}}{6}+\sum_{n=2}^{\infty}\left[\frac{\left|G_{n}\right|}{n^{2}}+\sum_{k=1}^{n-1} \frac{\left|G_{k} G_{n+1-k}\right| \cdot\left(H_{n}-H_{k}\right)}{n+1-k}\right] \\
= & \frac{3}{2}-\frac{\pi^{2}}{6}+\frac{1}{32}+\frac{5}{432}+\frac{1313}{207360}+\frac{42169}{10368000} \\
& +\frac{137969}{48384000}+\frac{1128119}{533433600}+\cdots \tag{20}
\end{align*}
$$

containing $\pi^{2}$ and positive rational coefficients only. Using Euler's formula $\pi^{2}=$ $6 \sum n^{-2}$, the latter may be reduced to a series with rational terms only.
Proof By (18) with $m=1$, one has

$$
\gamma_{1}=\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{k=1}^{n} \sum_{m=1}^{k}(-1)^{m}\binom{k}{m} \ln (m+1) .
$$

Using (13), we find that

$$
\frac{1}{n+1} \sum_{k=1}^{n} \sum_{m=1}^{k}(-1)^{m}\binom{k}{m} \ln (m+1)=\frac{1}{n+1} \sum_{k=1}^{n} \sigma_{k}-\frac{H_{n+1}}{n+1}+\frac{1}{(n+1)^{2}} .
$$

Thus

$$
\begin{aligned}
\gamma_{1} & =\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{k=1}^{n} \sigma_{k}-\sum_{n=0}^{\infty} \frac{\left|G_{n+1}\right| H_{n+1}}{n+1}+\sum_{n=0}^{\infty} \frac{\left|G_{n+1}\right|}{(n+1)^{2}} \\
& =\sum_{n=1}^{\infty} \sum_{m=1}^{\infty} \frac{\left|G_{n+1} G_{m}\right|\left(H_{m+n}-H_{m}\right)}{n+1}-\zeta(2)+1+\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n^{2}},
\end{aligned}
$$

since

$$
\sum_{n=1}^{\infty} \frac{\left|G_{n}\right| \cdot H_{n}}{n}=\zeta(2)-1 .
$$

For the latter, see e.g. [42, p. 2952, Eq. (1.3)], [15, p. 20, Eq. (3.6)], [11, p. 307, Eq. for $\left.F_{0}(2)\right]$, [6, p. 413, Eq. (44)]. Rearranging the double absolutely convergent series as follows

$$
\sum_{n=1}^{\infty} \sum_{m=1}^{\infty} \frac{\left|G_{n+1} G_{m}\right|\left(H_{m+n}-H_{m}\right)}{n+1}=\sum_{n=2}^{\infty} \sum_{k=1}^{n-1} \frac{\left|G_{k} G_{n+1-k}\right|\left(H_{n}-H_{k}\right)}{n+1-k}
$$

we finally arrive at (20).
Remark 2 It seems that the sum $\kappa_{1}:=\sum\left|G_{n}\right| n^{-2}=0.5290529699 \ldots$ cannot be reduced to the "standard" mathematical constants. ${ }^{12}$ However, it admits several interesting representations, which we give in Appendix.

Theorem 2 The first MacLaurin coefficient $\delta_{1}=\frac{1}{2} \ln 2 \pi-1$ admits a series representation similar to that for $\gamma_{1}$, namely

$$
\begin{equation*}
\delta_{1}=\sum_{n=1}^{\infty} \frac{1}{n} \sum_{k=1}^{n}\left|G_{k} G_{n+1-k}\right|+\frac{1-\ln 2 \pi}{2} \tag{21}
\end{equation*}
$$

Proof Proceeding analogously to the previous case and recalling that

$$
\sum_{n=2}^{\infty} \frac{\left|G_{n}\right|}{n-1}=-\frac{\gamma+1-\ln 2 \pi}{2}
$$

see e.g. [6, p. 413, Eq. (41)], [43, Corollary 9], we have

$$
\begin{align*}
\delta_{1} & =\sum_{n=0}^{\infty}\left|G_{n+1}\right| \sum_{l=0}^{n}(-1)^{l}\binom{n}{l} \ln (l+1) \\
& =\sum_{n=1}^{\infty}\left|G_{n+1}\right|\left(\sigma_{n}-\frac{1}{n}\right)=\sum_{n=1}^{\infty}\left|G_{n+1}\right| \sigma_{n}-\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n} \\
& =\sum_{n=1}^{\infty} \sum_{k=1}^{\infty} \frac{\left|G_{n+1} G_{k}\right|}{n+k}+\frac{\gamma+1-\ln 2 \pi}{2}=\sum_{n=1}^{\infty} \sum_{k=1}^{\infty} \frac{\left|G_{n} G_{k}\right|}{n+k-1}+\frac{1-\ln 2 \pi}{2} \\
& =\sum_{n=1}^{\infty} \frac{1}{n} \sum_{k=1}^{n}\left|G_{k} G_{n+1-k}\right|+\frac{1-\ln 2 \pi}{2}, \tag{22}
\end{align*}
$$

where in (22) we eliminated $\gamma$ by using the fact that $G_{1}=1 / 2$ and that the sum of $\left|G_{n}\right| / n$ over all natural $n$ equals precisely Euler's constant, see (6).

Corollary 1 The constant $\ln 2 \pi$ has the following beautiful series representation with rational terms only and containing a product of the Gregory coefficients

$$
\begin{align*}
\ln 2 \pi & =\frac{3}{2}+\sum_{n=1}^{\infty} \frac{1}{n} \sum_{k=1}^{n}\left|G_{k} G_{n+1-k}\right| \\
& =\frac{3}{2}+\frac{1}{4}+\frac{1}{24}+\frac{7}{432}+\frac{1}{120}+\frac{43}{8640}+\frac{79}{24192}+\cdots \tag{23}
\end{align*}
$$

[^7]This result directly follows from (21). It is worth noting that one can also readily derive a series with rational coefficients only for $\ln \pi$ (for instance, with the aid of the Mercator series).

Corollary 2 Euler's constant $\gamma$ admits the following series representation with rational terms

$$
\begin{align*}
\gamma= & 2 \ln 2 \pi-3-2 \sum_{n=1}^{\infty} \frac{1}{n+1} \sum_{k=1}^{n}\left|G_{k} G_{n+2-k}\right| \\
= & 2 \ln 2 \pi-3-\frac{1}{24}-\frac{1}{54}-\frac{29}{2880} \\
& -\frac{67}{10800}-\frac{1507}{362880}-\frac{3121}{1058400}-\frac{12703}{15806080}-\frac{164551}{97977600}-\cdots \tag{24}
\end{align*}
$$

which we have not been able to find in the literature. It follows from (5), (22) and the transformation

$$
\sum_{k=1}^{\infty} \sum_{n=1}^{\infty} \frac{\left|G_{k+1} G_{n}\right|}{n+k}=\sum_{n=1}^{\infty} \frac{1}{n+1} \sum_{k=1}^{n}\left|G_{k} G_{n+2-k}\right|
$$

### 2.4 Generalizations to the second-order coefficients $\delta_{2}$ and $\gamma_{2}$ via an application of the harmonic product

We recall the main properties of the harmonic product of sequences which are stated and proved in [12]. If $a=(a(1), a(2), \ldots)$ and $b=(b(1), b(2), \ldots)$ are two sequences in $\mathbb{C}^{\mathbb{N}^{*}}$, then the harmonic product $a \bowtie b$ admits the explicit expression:

$$
\begin{gather*}
(a \bowtie b)(m+1)=\sum_{0 \leqslant l \leqslant k \leqslant m}(-1)^{k-l}\binom{m}{k}\binom{k}{l} a(k+1) b(m+1-l), \\
m=0,1,2, \ldots \tag{25}
\end{gather*}
$$

For small values of $m$, this gives

$$
\begin{aligned}
(a \bowtie b)(1)= & a(1) b(1), \\
(a \bowtie b)(2)= & a(2) b(1)+a(1) b(2)-a(2) b(2), \\
(a \bowtie b)(3)= & a(3) b(1)+a(1) b(3)+2 a(2) b(2) \\
& -2 a(3) b(2)-2 a(2) b(3)+a(3) b(3), \\
& \text { etc. }
\end{aligned}
$$

The harmonic product $\bowtie$ is associative and commutative.

Let $D$ be the operator (known as the binomial transform) defined by

$$
D(a)(m+1)=\sum_{j=0}^{m}(-1)^{j}\binom{m}{j} a(j+1), \quad m=0,1,2, \ldots
$$

Then $D=D^{-1}$ and the harmonic product satisfies the following property:

$$
\begin{equation*}
D(a b)=D(a) \bowtie D(b) . \tag{26}
\end{equation*}
$$

In particular, if $a=\ln$, then $D(a)(1)=\ln 1=0$. By (13), we find that

$$
\begin{equation*}
D(\ln )(m+1)=\sum_{j=1}^{m}(-1)^{j}\binom{m}{j} \ln (j+1)=\sigma_{m}-\frac{1}{m}, \quad m=1,2,3, \ldots \tag{27}
\end{equation*}
$$

Therefore, if $a=\ln ^{2}$ then, by (25), (26) and (27), the following identity holds

$$
\begin{equation*}
D\left(\ln ^{2}\right)(m+1)=\sum_{\substack{0 \leqslant l \leqslant k \leqslant m \\ k \neq 0 \\ l \neq m}}(-1)^{k-l}\binom{m}{k}\binom{k}{l}\left(\sigma_{k}-\frac{1}{k}\right)\left(\sigma_{m-l}-\frac{1}{m-l}\right) . \tag{28}
\end{equation*}
$$

From this identity, we deduce the following theorem:
Theorem 3 The second coefficients $\gamma_{2}$ and $\delta_{2}$ may be given by the series

$$
\gamma_{2}=\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{\substack{0 \leqslant l \leqslant k \leqslant m \leqslant n \\ k \neq 0 \\ l \neq m}}(-1)^{k-l}\binom{m}{k}\binom{k}{l}\left(\sigma_{k}-\frac{1}{k}\right)\left(\sigma_{m-l}-\frac{1}{m-l}\right)
$$

and

$$
\delta_{2}=\sum_{m=1}^{\infty}\left|G_{m+1}\right| \sum_{\substack{0 \leqslant l \leqslant k \leqslant m \\ k \neq 0 \\ l \neq m}}(-1)^{k-l}\binom{m}{k}\binom{k}{l}\left(\sigma_{k}-\frac{1}{k}\right)\left(\sigma_{m-l}-\frac{1}{m-l}\right) .
$$

Proof Using (18) and Eq. (28), we get the following equalities:

$$
\begin{aligned}
\gamma_{2} & =\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{m=1}^{n} \sum_{j=1}^{m}(-1)^{j}\binom{m}{j} \ln ^{2}(j+1) \\
& =\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{m=1}^{n} D\left(\ln ^{2}\right)(m+1)
\end{aligned}
$$

$$
=\sum_{n=1}^{\infty} \frac{\left|G_{n+1}\right|}{n+1} \sum_{m=1}^{n} \sum_{\substack{0 \leqslant l \leqslant k \leqslant m \\ k \neq 0 \\ l \neq m}}(-1)^{k-l}\binom{m}{k}\binom{k}{l}\left(\sigma_{k}-\frac{1}{k}\right)\left(\sigma_{m-l}-\frac{1}{m-l}\right) .
$$

Similarly $\delta_{2}$ is

$$
\begin{aligned}
\delta_{2} & =\sum_{n=0}^{\infty}\left|G_{n+1}\right| \sum_{j=0}^{n}(-1)^{j}\binom{n}{j} \ln ^{2}(j+1) \\
& =\sum_{n=1}^{\infty}\left|G_{n+1}\right| D\left(\ln ^{2}\right)(n+1) \\
& =\sum_{m=1}^{\infty}\left|G_{m+1}\right| \sum_{\substack{0 \leqslant l \leqslant k \leqslant m \\
k \neq 0 \\
l \neq m}}(-1)^{k-l}\binom{m}{k}\binom{k}{l}\left(\sigma_{k}-\frac{1}{k}\right)\left(\sigma_{m-l}-\frac{1}{m-l}\right) .
\end{aligned}
$$

By following the same method, one may also obtain expressions for higher-order constants $\gamma_{m}$ and $\delta_{m}$. However, the resulting expressions are more theoretical than practical.

## Appendix: Yet another generalization of Euler's constant

The numbers $\kappa_{p}:=\sum\left|G_{n}\right| n^{-p-1}$, where the summation extends over positive integers $n$, may also be regarded as one of the possible generalizations of Euler's constant (since $\kappa_{0}=\gamma_{0}=\gamma$ and $\kappa_{-1}=\gamma-1=1$ ). ${ }^{13,14}$ These constants, which do not seem to be reducible to "classical mathematical constants", admit several interesting representations as stated in the following proposition.

Proposition 1 Generalized Euler's constants $\kappa_{p}:=\sum\left|G_{n}\right| n^{-p-1}$, where the summation extends over positive integers n, admit the following representations:

$$
\begin{equation*}
\kappa_{p}=\frac{(-1)^{p}}{\Gamma(p+1)} \int_{0}^{1}\left\{\frac{1}{\ln (1-x)}+\frac{1}{x}\right\} \ln ^{p} x \mathrm{~d} x, \quad \operatorname{Re} p>-1 \tag{29}
\end{equation*}
$$

$$
\begin{align*}
& =\underbrace{1}_{p-f{ }_{0}} \cdots \int_{0}^{1}\left\{\operatorname{li}\left(1-\prod_{k=1}^{p} x_{k}\right)+\gamma+\sum_{k=1}^{p} \ln x_{k}\right\} \frac{\mathrm{d} x_{1} \cdots \mathrm{~d} x_{p}}{x_{1} \cdots x_{p}}, \quad p=1,2,3, \ldots  \tag{30}\\
& =\sum_{k=2}^{\infty} \frac{(-1)^{k}}{k} \sum_{n=p+1}^{\infty} \frac{\left|S_{1}(n, p+1)\right|}{n!n^{k-1}}, \quad p=0,1,2, \ldots  \tag{31}\\
& =\sum_{k=2}^{\infty} \frac{(-1)^{k}}{k} \sum_{n=p}^{\infty} \frac{P_{p}\left(H_{n}^{(1)},-H_{n}^{(2)}, \ldots,(-1)^{p-1} H_{n}^{(p)}\right)}{(n+1)^{k}}, \quad p=0,1,2, \ldots  \tag{32}\\
& =\sum_{n \geqslant 1}^{\mathcal{R}} \frac{1}{n} \sum_{n \geqslant n_{1} \geqslant \cdots \geqslant n_{p} \geqslant 1}^{\sum_{1} \ldots n_{p}} \frac{1}{n_{1} \ldots} \\
& =\sum_{n \geqslant 1}^{\mathcal{R}} \frac{P_{p}\left(H_{n}^{(1)}, H_{n}^{(2)}, \ldots, H_{n}^{(p)}\right)}{n}, \quad p=1,2,3, \ldots \tag{33}
\end{align*}
$$
\]

where li is the integral logarithm function, $H_{n}^{(m)}:=\sum_{k=1}^{n} k^{-m}$ stands for the generalized harmonic number and $P_{m}$ denotes the sequence of polynomials

$$
\begin{aligned}
P_{0} & =1, \quad P_{1}\left(x_{1}\right)=x_{1}, \quad P_{2}\left(x_{1}, x_{2}\right)=\frac{1}{2}\left(x_{1}^{2}+x_{2}\right), \\
P_{3}\left(x_{1}, x_{2}, x_{3}\right) & =\frac{1}{6}\left(x_{1}^{3}+3 x_{1} x_{2}+2 x_{3}\right), \quad \ldots
\end{aligned}
$$

In particular, for the series $\kappa_{1}$ mentioned in Theorem 1 and Remark 2, this gives

$$
\begin{align*}
\kappa_{1} & =\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n^{2}}=-\int_{0}^{1}\left\{\frac{1}{\ln (1-x)}+\frac{1}{x}\right\} \ln x \mathrm{~d} x  \tag{34}\\
& =\int_{0}^{1} \frac{-\operatorname{li}(1-x)+\gamma+\ln x}{x} \mathrm{~d} x=\int_{0}^{\infty}\left\{-\operatorname{li}\left(1-\mathrm{e}^{-x}\right)+\gamma-x\right\} \mathrm{d} x  \tag{35}\\
& =\sum_{k=2}^{\infty} \frac{(-1)^{k}}{k} \sum_{n=2}^{\infty} \frac{H_{n-1}}{n^{k}}=\sum_{n \geqslant 1}^{\mathcal{R}} \frac{H_{n}}{n} . \tag{36}
\end{align*}
$$

[^9]Moreover, we also have

$$
\begin{align*}
\kappa_{1} & =\gamma_{1}+\frac{\gamma^{2}}{2}-\frac{\pi^{2}}{12}+\int_{0}^{1} \frac{\Psi(x+1)+\gamma}{x} \mathrm{~d} x  \tag{37}\\
& =\frac{\gamma^{2}}{2}+\frac{\pi^{2}}{12}-\frac{1}{2}+\frac{1}{2} \int_{0}^{1} \Psi^{2}(x+1) \mathrm{d} x, \tag{38}
\end{align*}
$$

where $\Psi$ denotes the digamma function (logarithmic derivative of the $\Gamma$-function).

Proof of formula (29) We first write the generating equation for Gregory's coefficients, Eq. (7), in the following form

$$
\begin{equation*}
\frac{1}{\ln (1-x)}+\frac{1}{x}=\sum_{n=1}^{\infty}\left|G_{n}\right| x^{n-1}, \quad|x|<1 \tag{39}
\end{equation*}
$$

Multiplying both sides by $\ln ^{p} x$, integrating over the unit interval and changing the order of summation and integration ${ }^{16}$ yield

$$
\begin{equation*}
\int_{0}^{1}\left\{\frac{1}{\ln (1-x)}+\frac{1}{x}\right\} \ln ^{p} x \mathrm{~d} x=\sum_{n=1}^{\infty}\left|G_{n}\right| \int_{0}^{1} x^{n-1} \ln ^{p} x \mathrm{~d} x, \quad \operatorname{Re} p>-1 \tag{40}
\end{equation*}
$$

The last integral may be evaluated as follows. Considering Legendre's integral $\Gamma(p+$ $1)=\int t^{p} \mathrm{e}^{-t} \mathrm{~d} t$ taken over $[0, \infty)$ and making a change of variable $t=-(s+1) \ln x$, we have

$$
\begin{equation*}
\int_{0}^{1} x^{s} \ln ^{p} x \mathrm{~d} x=(-1)^{p} \frac{\Gamma(p+1)}{(s+1)^{p+1}}, \quad \operatorname{Re} s>-1, \quad \operatorname{Re} p>-1 . \tag{41}
\end{equation*}
$$

Inserting this formula into (40) and setting $n-1$ instead of $s$ yield (29).

Proof of formula (30) Putting in (39) $x=x_{1} x_{2} \cdots x_{p+1}$ and integrating over the volume $[0,1]^{p+1}$, where $p \in \mathbb{N}$, on the one hand, we have

$$
\begin{equation*}
\underbrace{\int_{0}^{1} \cdots \int_{0}^{1} \sum_{n=1}^{\infty}\left|G_{n}\right|\left(x_{1} x_{2} \cdots x_{p+1}\right)^{n-1} \mathrm{~d} x_{1} \cdots \mathrm{~d} x_{p+1}=\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n^{p+1}} . ~}_{(p+1) \text {-fold }} \tag{42}
\end{equation*}
$$

[^10]On the other hand

$$
\int_{0}^{1}\left\{\frac{1}{\ln (1-x y)}+\frac{1}{x y}\right\} \mathrm{d} x=-\frac{\operatorname{li}(1-y)-\gamma-\ln y}{y} .
$$

Taking instead of $y$ the product $x_{1} x_{2} \cdots x_{p}$ and setting $x=x_{p+1}$, and then integrating $p$ times over the unit hypercube and equating the result with (42) yield (30).

Proof of formulas (31) and (32) Writing in the generating equation (11) $-x$ instead of $z$, multiplying it by $\ln ^{m} x / x$ and integrating over the unit interval, we obtain the following relation ${ }^{17}$

$$
\Omega(k, m)=(-1)^{m+k} m!k!\sum_{n=k}^{\infty} \frac{\left|S_{1}(n, k)\right|}{n!n^{m+1}},
$$

where

$$
\Omega(k, m):=\int_{0}^{1} \frac{\ln ^{k}(1-x) \ln ^{m} x}{x} \mathrm{~d} x, \quad k, m \in \mathbb{N} .
$$

By integration by parts, it may be readily shown that

$$
\Omega(k, m)=\frac{k}{m+1} \Omega(m+1, k-1),
$$

and thus, we deduce the duality formula:

$$
\sum_{n=k}^{\infty} \frac{\left|S_{1}(n, k)\right|}{n!n^{m+1}}=\sum_{n=m+1}^{\infty} \frac{\left|S_{1}(n, m+1)\right|}{n!n^{k}}
$$

Furthermore, the MacLaurin series expansion of $\mathrm{e}^{z}$ with $z=\ln (1-x)$ gives

$$
x+\ln (1-x)=-\sum_{k=1}^{\infty} \frac{\ln ^{k+1}(1-x)}{(k+1)!}, \quad x<1
$$

Hence

$$
\begin{aligned}
\int_{0}^{1}\left\{\frac{1}{\ln (1-x)}+\frac{1}{x}\right\} \ln ^{m} x \mathrm{~d} x & =-\int_{0}^{1} \sum_{k=1}^{\infty} \frac{\ln ^{k+1}(1-x)}{(k+1)!} \cdot \frac{\ln ^{m} x}{\ln (1-x)} \cdot \frac{\mathrm{d} x}{x} \\
& =-\sum_{k=1}^{\infty} \frac{\Omega(k, m)}{(k+1)!} \\
& =(-1)^{m} m!\sum_{k=1}^{\infty} \frac{(-1)^{k+1}}{(k+1)} \sum_{n=m+1}^{\infty} \frac{\left|S_{1}(n, m+1)\right|}{n!n^{k}}
\end{aligned}
$$

[^11]which is identical with (31) if setting $m=p$. Furthermore, it is well known that
$$
\frac{\left|S_{1}(n+1, m+1)\right|}{n!}=P_{m}\left(H_{n}^{(1)},-H_{n}^{(2)}, \ldots,(-1)^{m-1} H_{n}^{(m)}\right),
$$
see [17, p. 217], [37, p. 1395], [31, p. 425, Eq. (43)], [4, Eq. (16)], which immediately gives (32) and completes the proof.

Proof of formula (33) This formula straightforwardly follows from the fact that $\kappa_{p}=$ $F_{p}(1)$, see [11, p. 307, 318 et seq.], where $F_{p}(s)$ is the special function defined by

$$
F_{p}(s):=\sum_{n=1}^{\infty} \frac{\left|G_{n}\right|}{n^{p}} D\left(\frac{1}{x^{s}}\right)(n)=\sum_{n=0}^{\infty} \frac{\left|G_{n+1}\right|}{(n+1)^{p}} \sum_{k=0}^{n}(-1)^{k}\binom{n}{k}(k+1)^{-s}
$$

Proof of formulas (37) and (38) These formulas immediately follow from [10, Eqs. (3.21) and (3.23)] and (36).
